**FILIPINO FESTIVAL STALL HOLDERS TERMS AND CONDITIONS
7th and 8th June, 2008**

- 1 Subject to their agreement to the terms and conditions herein set down and subject further to the approval from the executive committee of **BAYANIHAN IN UK**, Individuals and Groups will be allocated a marquee(s) to sell, display and/or advertise their products, crafts etc.
- 2 The Stall Committee shall allocate stalls to stall holders subject to type of product sold or displayed, when applied for and when paid, (first come, first served) and the stall holder's requests. The decision of the Stall Committee is final and not subject to Arbitration or Litigation.
- 3 Stall holders will be responsible for providing their own facilities i.e. tables, chairs, electricity. There will be water available inside the vicinity of the park.
- 4 Stall holders may, if they wish, come on Friday afternoon, **6 June 2008** to help set up their stalls and ensure they are in the properly allocated area. **BAYANIHAN IN UK** officials will have their people in the park overnight.
- 5 Stall holders will be set up and ready by 8:00am on Saturday, **7 June 2008** and shall have cleaned up and vacated their area by 6:30pm on Sunday evening. Please note that for safety reasons, vehicles will not be allowed into the vicinity of the park (except on the parking spaces specifically reserved on purpose) after 9:30am Saturday and Sunday morning.
- 6 Stall holders will be responsible for the cleanliness of the area around their stalls. Adequate refuse bins, black bags, etc. will be provided by the stall holders who themselves will be responsible for the regular clearing of refuse into the skips that will be provided by the officials of **BAYANIHAN IN UK**. Stall holders that fail to observe this will be fined a minimum of £150.00 and may be banned from future events organized by **BAYANIHAN IN UK**. **PLEASE NOTE THAT THE COUNCIL NOW INSISTS THAT ALL STALL HOLDERS HAVE 2 RUBBISH BINS IN FRONT OF THEIR STALLS.**
- 7 Stall holders will ensure that they are up to date on all legal requirements with respect to their stalls. Food sellers will comply with current health and safety and hygiene regulations. **BE SURE YOU HAVE ADEQUATE FIRE EXTINGUISHERS REQUIRED BY YOUR BUSINESS.**
- 8 **Selling of ALCOHOLIC BEVERAGES will not be allowed except in designated Beer stall of BAYANIHAN IN UK.** Any stall holder found selling alcoholic beverages shall be banned from holding a stall in future events. **BAYANIHAN IN UK** has agreed with the Borough Council to be sole seller of alcoholic beverages on this event. **So please cooperate.**
- 9 Because of the fire hazards inherent in barbecue fires, it is imperative that coals and ashes from your barbecues should not be dumped on to the grass. After the event, stall holders should put out all fires by hosting them down with water and then place the ashes in rubbish bags and put them into the skips.
- 10 **All NON FOOD stall holders are not allowed to sell food and drinks in their stalls, including barbecue, softdrinks, water, wine and beer.**
